Letter from the ACBS Board President

2020 Board Actions and Initiatives

Throughout the year, the ACBS board worked on a variety of projects and initiatives. The following list shows some of these:

- The board supported the newly registered charity, the ACBS Foundation, by hiring a consultant to assist with developing policies and a development plan.
- The board continued to guide the work of our strategic teams in developing projects aligned with the strategic initiatives.
- The board released a public statement on Racism & Violence.
- The board worked to develop a closer working relationship with the DEI Committee, and has begun a process of examining how ACBS can be more welcoming to all of our members around the world.
- The board developed an aspirational Code of Conduct for ACBS members.
- The board and the Conference Strategy Committee (CSC) worked together with the ACBS staff to shift to an online conference as a result of the COVID-19 Pandemic. The board and CSC also made the difficult decision to go online for the 2021 conference.
- The board approved a Grants Committee proposal for an additional grant offering specifically targeting those living in low-and middle-income countries.
- The board approved an ongoing Membership Scholarship program for those living in low- and middle-income countries, and has already awarded 25 scholarships in 2020.
- The board voted to move the ACBS investments to an ESG funding opportunity available through our investment bank.

2019-2022 Strategic Plan

The ACBS Board strategic planning meeting was held in early 2019. Informed by ACBS member focus group data, and one on one interviews, a picture of the current state of the organization came into focus. The Board felt four areas were priorities for change, so that we better execute our mission:

- 1. Expanding and improving our digital presence Eric Morris Past Lead; Leann Harris Current Lead; Tiffany Rochester Champion
- 2. Centering Science Louise McHugh Lead; Jonathan Bricker Champion
- 3. **Creating a culture of empowerment and productivity** Jessica Borushok Lead; Laura Silberstein-Tirch Champion
- 4. Building a culture of competency to support effective dissemination in ACBS Robyn Walser Lead; Nanni Presti Champion

A Core Strategic Team was built for each pillar and the work has continued throughout 2020:

- All pillars submitted a sketch outline and received feedback from the board in late 2019 or early 2020.
- Each pillar worked to develop the projects most closely aligned with the strategic goals (this step in the process was protracted due to the COVID-19 Pandemic).
- The Centering Science and Creating a Culture of Empowerment and Productivity pillars additionally submitted final detailed plans to the ACBS Board in September of 2020. Selected projects, that most closely aligned with goals and with the best chance for success, will move forward.

ACBS Foundation

After the announcement of the ACBS Foundation at the Dublin World Conference, the new organization developed its founding policies and procedures which will inform the Foundation's work now and in the future.

The Foundation worked with a consultant to create a Development Plan to continue to move the work of the Foundation forward. The Foundation adopted as its goal to support existing activities within ACBS and explore additional areas for future development.

These activities include the announcement of a new funding mechanism for ground-breaking projects that share this aim in the realms of interventions, training, and research. The aim of the <u>ACBS</u>

<u>Foundation grant</u> is to finance projects and/or research that advances the understanding of how CBS principles can be used to impact social or environmental issues.

- Grant Start Dates, by September 1, 2021.

Asher Student Dissertation Award

This award is given to students based on their doctoral dissertation proposal related to the use of Contextual Behavioral Science with children/adolescents. Michael J. Asher, Ph.D., ABPP passed away in 2016 and was a clinical psychologist at Behavior Therapy Associates, P.A. since 1988. He was passionate about his work, loved psychology, cognitive behavior therapy, and especially enjoyed learning about and practicing ACT. Dr. Asher greatly impacted the lives of many and his contribution to the field of psychology and education was significant. He will be remembered fondly. This year the awards went to:

- First Prize **Olivia Gratz**, Western Michigan University, for her project "Using Functional Analytic Psychotherapy to Develop Social Skills in Adolescents with High Functioning Autism".
- Second Prize **Caitlyn Gumaer**, Claremont Graduate University, for her project "Evaluating the Effects of an Acceptance and Commitment Therapy Behavioral Parent Training Program on Children with Autism Spectrum Disorder and their Parents".

JCBS - Journal of Contextual Behavioral Science

The Journal of Contextual Behavioral Science (JCBS) is the premier source for important developments in all areas of contextual behavioral science. JCBS is distributed to most major academic libraries and included as a benefit of ACBS membership.

2020 was the third year that *JCBS* received a Clarivate Analytics (formerly of Thomson Reuters) Journal Impact Factor in the Journal Citations Report. The impact was estimated at 1.523, a slight decrease from our Impact Factor of 1.890 at the end of 2018. The number of citations received by the Journal increased to 662 citations compared to 474 citations at the end of 2018. This, combined with the increases in the number of submissions along with diversity of topics, authors, and methodologies, is a good sign that *JCBS*' impact will continue to grow.

In 2020 JCBS welcomed Michael Levin, Ph.D., as the new editor in chief, replacing the previous editor in chief, Emily Sandoz, Ph.D. Michael served as an associate editor prior to being appointed to this position. Michael has transferred to a new editorial management system, updated the website, removed outdated information, put up new guidelines for authors, changed submission categories, set up new author notifications, and set up new reviewer notifications. Michael has been in contact with Elsevier to get *JCBS* set up in PubMed and to increase the efficiency of indexing.




